### *Implementation of mandate*

**★51. Mr M E Nchabeleng (Limpopo: ANC) to ask the Minister of Basic Education:**

Whether her department has implemented the recommendations of the Basic Education Sector Lekgotla that was held in January 2018; if not, why not; if so, (a) how has such a Lekgotla assisted his department to implement its mandate and (b) what are the further relevant details? CO153E

### *Comprehensive Sexual Education Programme*

**★38. Ms D C Christians (Northern Cape: DA) to ask the Minister of Basic Education:**

(a) What is the planned date for the implementation of the new Comprehensive Sexual Education Programme, (b) when will it be available for public participation, (c) what feedback has been received from (i) schools, (ii) the public and (iii) various stakeholders thus far and (d) what is wrong with the current programme that is being replaced? ### *Improving school infrastructure*

What is the progress regarding her department's programme of (a) eradicating unsafe school ablution facilities and (b) improving school infrastructure following the tragic death of a certain learner (details furnished)? CO154E

### *Unreliable learner transport*

Whether she has been informed that learner transport at Tlamelang Special School in Gelukspan, North West often arrives late or does not arrive at all; if not, what will her department do to ensure that such learners are provided with quality and reliable transport; if so, what is her department doing to address the situation? ### *Promoting teaching as profession*
