What (a) monitoring and (b) evaluation have been undertaken by her department to ensure that the R17,1 billion that was allocated for infrastructure projects by the Department of Public Works and Infrastructure is utilised effectively (details furnished)?

(2) whether she will outline plans to further reach such objectives within the remaining time frame; if not, why not; if so, what plans?
